## Wolves alter elk hunts

I am writing to clarify some of the statements in Mr. Wilkinson's column a few weeks ago about the current state of outfitting and elk hunting in northwestern Wyoming. I could write 20 pages about how wolves have changed hunting and outfitting in the area, but I will be brief. Obviously, Mr. Wilkinson is not familiar with the situation we are in here. I shook my head in disbelief after reading his column. Most hunters looking at booking an elk hunt in the Jackson area know about the wolf situation and how it has reduced elk numbers in certain areas. Outfitters are not keeping a big secret from their clients about how

wolves have reduced elk numbers.

I personally know the outfitter who has stated on his website, "Great 2011 hunting season; 28 bulls killed." But in order to harvest 28 bulls, this outfitter is taking hunters out of three separate hunting camps, and he is hunting over an unreal amount of area. Twenty-eight bulls out of threecamps is roughly nine bulls per camp — not that impressive compared with what the same camps historically produced pre-wolf.

Most outfitters around the Jackson area do still have high success rates with elk, but one of two things has happened to their business. Either they are taking a lot fewer clients to keep their success up, or they have bought more camps in an effort to take fewer clients in one area, such as the above outfitter. Outfitting in this part of Wyoming has changed, and outfitters are trying to adapt.

This is his marketing for him to stay employed as a columnist. And the same would ring true for the outfitters. They are marketing their business as supplying the best that they can, regardless of the numbers of both prey and predator.
