Abraham Kuyper once stated, "In the total expanse of human life there is not a single square inch of which the Christ, who alone is sovereign, does not declare, 'That is mine!'" The Holy Bible reveals Almighty God is the sovereign Lord! He is the supreme authority. For His glory and mankind's benefit, he has created four chief governments of men. They are self-government, family government, church government, and civil government. Each is a delegated authority that is accountable to the supreme authority of God. Whenever these authorities violate their God-ordained jurisdiction, there must be an appeal to God and to higher law to call the offending delegated authority back to its lawful jurisdiction.

The church of Jesus Christ is a lawful governmental authority instituted by God. Our Lord declared, "Upon this rock I will build my church and the gates of hell will not prevail against it" (Matthew 16:18). To his church, he has granted the keys to the kingdom of heaven. He promised "whatever you bind on earth will be bound in heaven,

and whatever you loose on earth will be loosed in heaven."

Today, we as representatives of The Church of Jesus Christ, do on this 14 day of July, in the year of our Lord 2015, come to exercise that God-ordained authority. We come to hold this federal court and the Supreme Court of the United States of America accountable before the Court of Almighty God. In fact, we hold it in contempt of the Court before whom every knee shall bow and every tongue confess that Jesus Christ is Lord.

In so doing, we, by the authority of God's Word and without reservation, will address the several rulings pronounced by the courts of America that have banned God from the public life of our nation, codified evil into law, and invoked the wrath of God upon our perverse and blood stained nation.

For a truth, we have come here today to demonstrate the reality of Proverbs 28:4, which states, "Those who forsake the law praise the wicked, But such as keep the law contend with them."

BEHOLD THE CHARGES

We will now cite 8 specific Court Decisions that prove, beyond a reasonable doubt that the Courts of the United States of America have crumbled our Biblical and historical foundations. They helped pave the way to reestablish our nation on the sinking sand humanistic policies of unregenerate minds. They have created an America spoken by the prophet Isaiah, "Justice is turned back, and righteousness stands afar off; For truth is fallen in the street, and equity cannot enter. So truth fails, and he who departs from evil makes himself a prey. Then the LORD saw it, and it displeased Him that there was no justice." The following unjust decrees serve as the basis of the charges leveled against the Supreme Court.

FIRST CHARGE: Everson vs. Board of Education. Everson vs. Board of Education was the Supreme Court Decision that opened the door to remove the knowledge of God from the public life of our nation. The Hugo Court in 1947, without any historic precedent, fabricated the "Separation of Church and State" myth that plagues us to this day. This phrase, Separation of Church and State, is not discovered in any of America's founding documents. It came from a private letter between President Thomas Jefferson and the Danbury Baptists in Connecticut. The Baptists had some concerns about a national religion being formed and Jefferson alleviated their fears by stating "There was a high wall of separation between church and state." The original line of separation was between the federal government and the states and church. After Everson vs. Board of Education the line shifted. The new line separated the federal government and the states from the church.

GOD'S RULING: Hear the word of the LORD, you children of Israel, for the LORD brings a charge against the inhabitants of the land: There is no truth or mercy or knowledge of God in the land. By swearing and lying, killing and stealing and committing adultery, they break all restraint, with bloodshed upon bloodshed. Therefore the land will mourn.

SECOND CHARGE: Engle vs. Vitale (1962). The Supreme Court silenced the prayers of our children in the public schools of America. The prayer targeted for destruction stated, "**Almighty God, we acknowledge our dependence upon Thee, and we beg Thy blessings upon us, our parents, our teachers, and our country.**" Since this ruling, untold devastation has come upon our children, our families, our schools, and our nation.

GOD'S RULING: It is written: But Jesus said, "Let the little children come to Me, and do not forbid them; for of such is the kingdom

of heaven" (Matthew 19:14). "But whoever causes one of these little ones who believe in Me to sin, it would be better for him if a millstone were hung about his neck, and he were drowned in the depth of the sea" (Matthew 18:6).

THIRD CHARGE: Abington vs. Schempp (1963). The Supreme Court removed the Bible from the education of our children in public schools. The knowledge of God was replaced with metal detectors, condoms, drugs, sexual immorality, and violence of unprecedented magnitude.

GOD'S RULING: The fear of the Lord is the beginning of knowledge, But fools despise wisdom and instruction (Proverbs 1:7). The fear of the Lord is the beginning of wisdom, And the knowledge of the Holy One is understanding (Proverbs 9:10). To the law and to the testimony! If they do not speak according to this word, it is because there is no light in them (Isaiah 8:20). Beware lest anyone cheat you through philosophy and empty deceit, according to the tradition of men, according to the basic principles of the world, and not according to Christ (Colossians 2:8).

FOURTH CHARGE: Roe vs. Wade (1973). The Supreme Court removed the humanity and personhood of the preborn. With one stroke of a pen, the laws that once protected the most vulnerable were struck down and it became open season to kill precious babies in the womb. As a result, hell has enlarged its mouth to devour one-third of an entire generation. America has committed domestic terrorism in the womb, and we are reaping terrorism in our streets. Our nation is defiled, and the innocent blood of our children cries out to God for vengeance.

GOD'S RULING: It is written, You shall not murder (Exodus 20:13). Since you did not hate bloodshed, bloodshed will pursue you (Ezekiel 35:6). They even sacrificed their sons and their daughters to demons, and shed innocent blood, the blood of their

sons and daughters, whom they sacrificed to the idols of Canaan; And the land was polluted with blood. Thus they were defiled by their own works, and played the harlot by their own deeds. Therefore the wrath of the LORD was kindled against His people, So that He abhorred His own inheritance. And He gave them into the hand of the Gentiles, And those who hated them ruled over them (Psalms 106:37-41).

FIFTH CHARGE: Stone vs. Graham (1980). The Supreme Court stripped the Ten Commandments from the walls of our public classrooms, removing the foundation upon which the moral, legal, and ethical freedoms of America rest. It declared, *“If the posted copies of the Ten Commandments are to have any effect at all, it will be to induce the schoolchildren to read, meditate upon, perhaps to venerate and obey, the Commandments.”*

GOD’S RULING: It is written: Because they had not obeyed my laws but had rejected my decrees...I also gave them over to statutes that were not good and laws they could not live by (Ezekiel 20:24-25). Woe to those who call evil good, and good evil; Who put darkness for light, and light for darkness; Who put bitter for sweet, and sweet for bitter (Isaiah 5:20). It is time for You to act, O Lord, For they have regarded Your law as void (Psalms 119:126).

SIXTH CHARGE: Planned Parenthood vs. Casey (1992). The Supreme Court reiterated the lie of the serpent in the Garden (Genesis 3) that man can become as “god”. It declared that man can determine his own reality, standards, and meanings apart from the objective truth of Almighty God. In a joint majority opinion, Kennedy, O’Connor, and Souter said, *“At the heart of liberty is the right to define one’s own concept of existence, of meaning of the universe, and the mystery of human life.”*

With this statement the Supreme Court declared itself to be “God,” and discarded its historical reliance on a transcendent

standard. Eric Harris and Dylan Klebold lived out this newly created standard. They walked into their high school in Columbine, Colorado and mercilessly murdered 13 of their peers and then committed suicide. Eric printed this statement on the internet before his murderous rampage, “My belief is that if I say something, it goes. I am the law, and if you don’t like it, you die... feel no remorse, no sense of shame.” (Washington Post, April 29th, 1999)

GOD’S RULING: It is written, *“Furthermore, since they did not think it worthwhile to retain the knowledge of God, he gave them over to a depraved mind, to do what ought not to be done. They have become filled with every kind of wickedness, evil, greed and depravity. They are full of envy, murder, strife, deceit, and malice. They are gossips, slanderers, God-haters, insolent, arrogant and boastful; they invent ways of doing evil; they disobey their parents; they are senseless, faithless, heartless, ruthless. Although they know God’s righteous decree that those who do such things deserve death, they not only continue to do these very things but also approve of those who practice them.”* Romans 1:28-32

SEVENTH CHARGE: Lawrence vs Texas (2003) The Supreme Court ruled, on June 26, 2003, in *Lawrence v. Texas* that there is a constitutional right to homosexual sodomy. In one fell swoop, this court rejected God, His Law, over 4,000 years of history, and its own past precedent, to declare sodomy, in all of its perverse forms, a constitutional right in America. Homosexuality means the burning out of man. It will destroy those who practice this perversion and nations that condone it.

GOD’S RULING: It is written, *“You shall not lie with a male as with a woman. It is an abomination”* (Leviticus 18:22). Therefore God also gave them up to uncleanness, in the lusts of their hearts, to dishonor their bodies among themselves, who exchanged

the truth of God for the lie, and worshiped and served the creature rather than the Creator, who is blessed forever. Amen. For this reason God gave them up to vile passions. For even their women exchanged the natural use for what is against nature. Likewise also the men, leaving the natural use of the woman, burned in their lust for one another, men with men committing what is shameful, and receiving in themselves the penalty of their error which was due (Romans 1:24-27).

EIGHTH CHARGE: GAY MARRIAGE. In *Obergefell v. Hodges*, the Supreme court of the United States held in a 5–4 decision that the fundamental right to marry is guaranteed to same-sex couples by both the Due Process Clause and the Equal Protection Clause of the Fourteenth Amendment to the United States Constitution. In this decision SCOTUS created a new civil right that was never part of the constitution. “Gay Marriage” is an oxymoron. The courts cannot make straight what God has called crooked. America should not tolerate what God deems intolerable. Turning moral wrongs into civil rights is a recipe for national disgrace and disaster.

GOD’S RULING: It Is Written, *“And He answered and said to them, “Have you not read that He who made them at the beginning ‘made them male and female,’ and said, ‘For this reason a man shall leave his father and mother and be joined to his wife, and the two shall become one flesh (Matthew 19:4, 5)?” “But we know that the law is good if one uses it lawfully, knowing this: that the law is not made for a righteous person, but for the lawless and insubordinate, for the ungodly and for sinners, for the unholy and profane, for murderers of fathers and*

murderers of mothers, for manslayers, for fornicators, for sodomites, for kidnappers, for liars, for perjurers, and if there is any other thing that is contrary to sound doctrine, according to the glorious gospel of the blessed God which was committed to my trust” (1 Timothy 1:9-11).

The Supreme Court of the United States of America has sinned against God in its rendering of these decisions! Far from warning us not to sin against God and His Law, it has informed us with a “new enlightenment” from a “living” Constitution that sodomy, like abortion before it, is now a protected “right”. According to Psalms, they have framed mischief by law. It is high treason against God and our nation.

Yes, the Supreme Court of the United States of America has betrayed our God, our nation, our people, our children, and has invited the wrath of Almighty God to come upon us – all of us!

These unjust and wicked rulings have violated the Biblical mandate to judge justly. The Supreme Court violated their constitutional responsibility. By these unjust rulings, they forfeited all moral authority. Therefore, by the authority invested in us as ministers of the Gospel of the Kingdom we cancel these wicked decisions. We render them null and void. We prohibit their enforcement upon America and its citizens. We declare with one voice that these wicked decrees are no longer binding upon us, our children, or our nation May God watch over his word to perform it and the future reflect the truths stated today in Jesus’ mighty name!
